Areas of Regulation

- Administrative agencies handle two areas of public concern:
 - Economic regulation
 - Public welfare agency regulation

Economic Regulation

- Three areas
 - Administrative approvals for certain types of businesses or equipment
 - Regulate securities and financial businesses
 - Completely regulate some industries

- Protects the public
 - Health
 - Safety
- Protection
- Entitlement programs

Features of Administrative Agencies

- Regulate only specified subject matter areas
- Well defined hierarchy
- More flexibility than legislative bodies

- Primary interpreters and enforcers of congressional statutes
- Created by enabling legislation
- Four types of agencies:
 - Line
 - Independent
 - Government
 - Quasi-official

Nature of Administrative Agencies

- Congress controls agencies four ways:
 - Creates and defines agency's powers
 - Confirms appointments of the heads of the agencies
 - Controls the agency budget
 - May reorganize or abolish the agency

 - Power to conduct physical inspections
- Record keeping requirements
- Investigatory powers
- Enforcement powers

Marshall v. Barlow's, Inc. Landmark Case

- US Supreme Court articulated a different standard than that used for criminal law when seeking a search warrant
- Explains why a different warrant-procurement process should be applied for criminal law and administrative agency searches
